- Overall poverty rate **13.4%**
- Child poverty rate **18.4%**

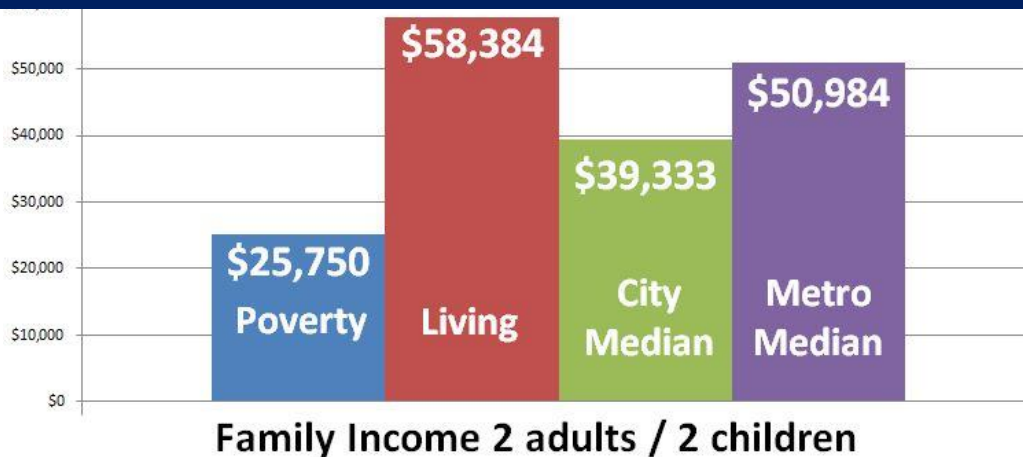
Memphis in 2017

- Overall poverty rate **24.6%**
 - Second highest rate of overall poverty among cities with populations greater than 1,000,000
- Child poverty rate **39.0%**
 - Second highest rate of child poverty among cities with populations greater than 1,000,000

Living wage- hourly rate that an **individual** must earn to support their family, if they are working full-time (40 hours a week = 2080 hours per year).

Poverty Wage- The poverty threshold is an administrative threshold defined by the Department of Health and Human Services to determine eligibility for certain financial assistance from the federal government
